3. REQUIREMENTS AND CONDITIONS

1. Performance Guarantee: The winning bidder is required to submit a performance guarantee amounting to 5% of the total contract value. This guarantee ensures the completion of the project in accordance with the contract specifications and timeline. The exact percentage will be stipulated in the final contract.
2. Pre-Bid Meeting: A mandatory pre-bid meeting is scheduled for June 7, 2025, at 1:30 PM. This meeting will provide clarifications on the RFQ and bidding process. Failure to attend will disqualify the bidder from submitting a proposal.
3. Relevant Working Experience: Suppliers must have demonstrable experience working on similar projects, preferably with international organizations such as the UN or NGOs. Evidence of past performance, including references, should be provided as part of the bid.
4. Bank Account: All suppliers must have an operational business bank account in the company's name. Payments will be made to the company's registered bank account.
5. Business License: Only suppliers with a valid and current business license are eligible to bid. Suppliers must provide a copy of their license and expired, or invalid licenses will result in disqualification.
6. Legal Status: Bidders must be legally registered entities capable of entering into binding contracts under Afghanistan law. Evidence of legal status, such as articles of incorporation, must be provided.
7. Non-Listing on UN Sanctions: Bidders must certify that they are not listed on the UN Security Council Sanctions List or any other relevant sanctions list. Suppliers on these lists are automatically disqualified from the bidding process.
8. No Involvement in Terrorism: Suppliers must declare that they do not support, finance, or have any affiliation with terrorism or terrorist groups. AOSD reserves the right to disqualify any bidder found to be in violation of this clause, with potential further legal consequences.

9. Local Presence of Suppliers (Mandatory Requirement)

Bidders must have an established and verifiable presence in close proximity to the project location. This is a mandatory requirement to ensure timely and consistent delivery of essential supplies.

The supplier will be responsible for the weekly and monthly provision of the following items:

- Wheat Flour (قزاقی) آرد درجه اول
- Salt نمک با کیفیت عالی آیدین
- Yeast خمیر مایه
- Baking Soda پولی
- Liquid Gas گاز مایع

Other agreed-upon food and non-food items essential to the project

The local presence will enable efficient coordination, immediate response to needs, and consistent quality assurance. Suppliers lacking a nearby operational base or reliable local partnership will not be considered eligible for this bid

4. QUOTE SUBMISSION

All quotations must be submitted in a sealed envelope with the RFQ number clearly marked. Bidders must ensure they provide all required documentation, including business registration, tax clearance certificate, and proof of similar project experience.

Submission Deadline: All quotations must be received by AOSD no later than June 12, 2025, 03:00 PM – Kabul Time. Late submissions will not be considered.

5. REJECTION OF AWARD

AOSD reserves the right to reject any or all quotations without assigning any reason. Rejection may also occur if there is misrepresentation, conflict of interest, or non-compliance with RFQ requirements.

6. ELIGIBILITY AND DISCLAIMERS

ELIGIBILITY CRITERIA

1. Relevant Working Experience: Suppliers must have a minimum of 3 years of demonstrable experience in supplying similar goods or services. Preferably, suppliers should have experience working with international organizations such as the UN, NGOs, or other recognized agencies. Bidders must provide supporting evidence, including references, past contracts, or performance certificates.
2. Business License: Suppliers must possess a valid and current business license issued by the appropriate Afghan authorities. Copies of the license must be submitted with the bid. Expired or suspended licenses will not be considered.
3. Legal Status: The bidder must be a legally registered entity, fully capable of entering into binding contracts under Afghan law. Proof of legal registration (incorporation documents, tax ID, etc.) must be provided.
4. Financial Capacity: The supplier must have the financial capability to execute the contract. Bidders should submit their company's Current Bank Statement including their company's financial statements for the last two fiscal years, demonstrating adequate resources to fulfill the contract.
5. Bank Account: All suppliers must have an operational business bank account in the company's name. Payments will be made exclusively to the company's registered bank account.
6. The winning bidder will also need to provide a performance guarantee equivalent to 5% of the total contract value before contract signing.

7. Compliance with National and International Laws: The supplier must comply with all relevant Afghan national laws, international regulations, and industry standards, including labor laws, anti-corruption laws, and human rights obligations.

8. Pre-Bid Meeting Attendance: Attendance at the mandatory pre-bid meeting is required. Suppliers must attend the scheduled meeting on June 7, 2025, at 1:30 PM at AOSD 's office. Failure to attend will result in disqualification from the bidding process.

9. Tax Compliance: Suppliers must provide a valid tax clearance certificate from the Ministry of Finance (MoF) of Afghanistan, confirming that they have complied with all tax obligations.

10. Non-Sanctioned Entities: The supplier must not appear on the UN Sanctions List or any similar international or national sanctions lists.

11. Anti-Terrorism Declaration: Suppliers must certify that they are not involved in, nor support, any activities related to terrorism or organized crime.

NON-ELIGIBILITY CRITERIA

1. Conflict of Interest: Suppliers who are found to have any form of conflict of interest with AOSD personnel, partners, or board members are not eligible. Suppliers must declare any potential conflicts of interest upon bid submission.

2. Fraud and Misrepresentation: Any supplier that provides false or misleading information or engages in fraudulent activities at any stage of the procurement process will be disqualified and excluded from future opportunities with AOSD .

3. Invalid or Expired Licenses: Suppliers without a valid business license or those whose licenses are expired, revoked, or suspended will not be considered for participation.

4. Financial Instability: Companies that are financially unstable or facing bankruptcy, insolvency, or significant financial losses will be excluded from the bidding process.

5. Sanctioned Entities: Suppliers that are on any sanctions lists, such as the UN Security Council Sanctions List or other national or international sanctions, are ineligible to participate in this procurement process.

6. Terrorism and Criminal Activity: Companies involved in, or supporting, terrorism, criminal activity, or any activities linked to organized crime will be immediately disqualified.

7. Non-Compliance with Procurement Requirements: Suppliers that do not comply with the mandatory pre-bid meeting, submission requirements, or fail to adhere to procurement conditions outlined in the RFQ will not be eligible.

8. Environmental and Social Responsibility Violations: Suppliers with a history of violating environmental laws or social responsibility standards will be excluded from participation.

Disclaimer:

AOSD reserves the right to cancel the procurement process at any stage without prior notice or explanation. Bidders bear all costs related to the preparation and submission of their bids, and AOSD will not be liable for any losses incurred.

Right to Accept or Reject:

AOSD reserves the right to accept or reject any bid, in whole or in part, based on financial and technical considerations, in its best interest. The final decision will be based on a fair evaluation process.

7. COST OF PROVIDING QUOTES

All costs associated with preparing and submitting a quote will be borne by the supplier. AOSD will not reimburse these costs under any circumstances.

8. CLARIFICATION AND AMENDMENTS OF REQUEST FOR QUOTATION

Bidders may request clarifications or submit questions to the AOSD contact person up until June 10, 2025. AOSD reserves the right to issue amendments to the RFQ based on bidder questions or organizational requirements.

1. Payment of all applicable taxes and duties as required by the Afghanistan Ministry of Finance (MoF). The required tax deductions must be clearly indicated in the financial proposal. And the AOSD reserve the rights to deduct the required taxation and deposited to the relevant Government Bank Account.
2. Adherence to labor laws and standards, ensuring the fair treatment of workers and maintaining a safe and healthy work environment.
3. Any other legal requirements necessary to conduct business in Afghanistan.

Failure to comply with these policies and legal requirements may result in disqualification from the bidding process, termination of the contract, and potential legal action.
